Jatindra Rajendra Mahavidyalaya, Amtala, Murshidabad organized a one day state level seminar on "Euthanasia: Right to Die with Dignity" on the 3<sup>rd</sup> of April in 2024 at the Master Seminar Hall of the college by the Department of Philosophy in collaboration with the IQAC of the college. The resource person was Sri Kalyan Mukherjee, Assistant Professor of Department of Philosophy, Sewnarayan Rameswar Fatepuria College, Beldanga, Murshidabad. He focused on euthanasia from the ethical perspective, giving a positive argument in favour the right to die with dignity. The dignitaries on the dias were Prof. Kalyan Mukherjee, the resource person for the keynote address, Prof. Geetali Bera, Associate Professor of Philosophy, Prof. Subhadip Mukherjee, IQAC Coordinator, Prof. Rina Mukherjee, Academic Council, and Prof. Pranab Ghosh, Convener of Seminars for the Department of Philosophy.

The programme was started at 12 p.m. with the opening ceremony. It began with the felicitation of the chief guest and other dignitaries with the flower of bouquet and enkindling of a lamp. Then a very warm welcome was addressed by the Principal, who clarified its terminological aspects and outlined some famous examples.



Prof. Kalyan Mukherjee delivered his keynote address on topic – "Euthanasia: Right to Die with Dignity". He recalled the debate on euthanasia that once again re-embarkd on the recent legalization of passive euthanasia by the Supreme Court of India. With this provision, India has joined leagues of counties where euthanasia is legal in one or the other way. On one side, Prof. Kalyan says that the Supreme Court decision brought a ray of hope to some while some have expressed their apprehensions. This is important to understand what has changed over the period, how the dynamics of forces working around euthanasia, some in favor or opposition, has changed over the

period, so passive euthanasia has become a possibility now. He concluded in his review that an attempt to revisit this controversial yet important concept of euthanasia in the current context is much needed.

The programme was summed up with votes of thanks and the distribution of a packet of refreshment to the students.

#### THEME OF SEMINAR

The term euthanasia originated in Greece and meant a good death. Debates about the ethics of euthanasia date from ancient Greece and Rome. It is argued that euthanasia should be understood within a historical context, as a protest against medical power and as a way to bring about good death. Within the euthanasia debate, two paradoxes are identified which make the issue inherently complex and hard to regulate. The first paradox results from the dialectical relation between individual autonomy and relief of suffering as the major justifications of euthanasia. Although euthanasia represents an ultimate effort to give the individual patient control over his dying, the result of the debate is an increase of medical power. The second paradox is that although euthanasia emerged from a commitment to good death, it is resulting in a reduced range of options to bring about good death.

Worldwide acceptance of euthanasia in some of the other forms and gradual legalization led to a great responsibility on physicians. History has already provided incidents of exploitation of such concepts. Physicians have to be aware and keep enough safeguards while adopting such practices.

Euthanasia will remain a major controversy because first euthanasia is illegal and yet, in its passive form, practiced in many hospitals. Second, medical advances have made it possible to prolong life furthermore artificially; we must all contend with the reality that financial constraints are an essential consideration in modern healthcare provision. Finally, there is an ethical difficulty in interpreting the concept of a patient's right, or autonomy, vs the rights and duty of a doctor.
