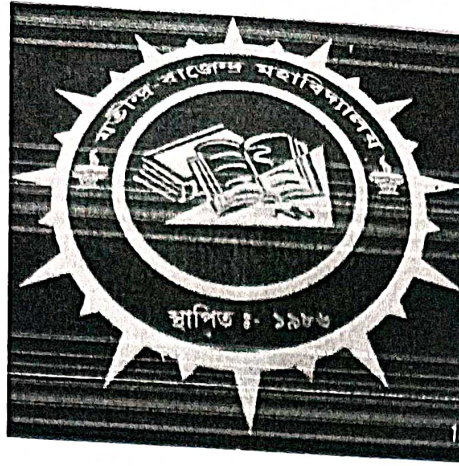

Department of Political Science arranged a Value-Added Course on 'Individual: Rights and Laws (Indian Context)' in the session 2022-2023 (course duration: 16th June, 2023 to 26th June, 2023). All the faculty members (total 4 faculties with one faculty from the English department and one another reputed lawyers joined in this course from the Berhampore George Court) enthusiastically involved with this course and motivate the students greatly. The course was open to all even semester students of the institution. There was a sufficient enrolment of students with participation of both boys and girls (total participants were 110). The prime **objective** of the course has been to introduce in our students the Multi-Dimensional Interpretation of Individual: Rights and Laws (Indian Context) enables them to decipher the complex societal relationships from the paradigm of Individual rights and laws. The course will be acquainted with Individual Rights and Laws. Students will cultivate a sense of responsibility towards themselves. The course also will enrich them aware about modern rights and laws to increase employability. They will also experience a sense of Rights and Laws as a democratic citizen of India.

The **outcome** of this course is to disseminate the idea of legal right is defined as any action of a person which is permitted by law and its debasement is punishable by law. These rights are equally available to every citizen without any discrimination but there are very few of them which are known to the general public. It is evident that the Indian Constitution is the largest written constitution in the world and is difficult to remember; therefore, some of the important rights and laws that every Indian should know are discussed in this article. Every Indian citizen should know some basics of the Rights and if they do so, their life will be more conducive in terms of leaving a lawful life. We can start to do so by learning the followings such as: The Right to Life, The Right to Equality, The Right to Information, The Right to Education, The Right of Parents to be

Maintained by their Children, The Right to Equal pay for Equal work, The Rights of a woman when arrested, The Right to free legal aid, The Right to Vote, The POCSO Act, The Special Provision for Women (Maternity Leave, Domestic Violence).

A basic understanding of the law is essential for every individual that empowers them to defend their rights. A person can only ask for justice if he/she knows about the right and the wrong of the laws; therefore, it is the need of the hour to familiarize every individual with important rights and laws. An empowered country builds upon the empowered citizens and the knowledge of the Constitution and Rights certainly prepares the citizens for the challenges. This knowledge and wisdom help the individuals to grow legally and confidently. Thus, we can say that if the citizens are empowered, the country is also empowered. The Government institutions and individuals have a responsibility to uphold and promote the Rights by enacting and implementing Laws, Policies, and practices that ensure equal treatment and non-discrimination for all.

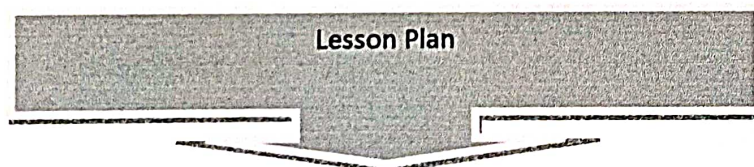
